## INVITATION TO BID

The **Technical Education and Skills Development Authority (TESDA)**, through the General Appropriations Act for CY 2017 intends to apply the sum of **Sixteen Million Six Hundred Forty-Eight Thousand Eight Hundred Twenty-Five Pesos and 50/100 (Php16,648,825.50)** being the Approved Budget for the Contract (ABC) to payment for the **Provision of Security Services Requirements for TESDA Central Office (April 1, 2017 – December 31, 2017)**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

The **Technical Education and Skills Development Authority (TESDA)** now invites suppliers to apply for eligibility and to bid for the **Provision of Security Services Requirements for TESDA Central Office (April 1, 2017 – December 31, 2017)**. Bidders must have completed, at least one (1) contract that is similar to the contract to be bid within the five (5) year period from the date of the submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act".

Interested bidders may obtain further information from **Technical Education and Skills Development Authority (TESDA)** and inspect the Bidding Documents at the address given below on 25 January 2017 from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be purchased by interested Bidders on 25 January 2017 from the address below and upon payment of a non-refundable fee of **Twenty-Five Thousand Pesos Only (Php25,000.00)** for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bids must be submitted to the BAC Secretariat, CSA Conference Room, 2<sup>nd</sup> Floor, TESDA Administration Building, Taguig City on or before 28 February 2017 at 10:00 A.M. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Clause 18 of Instructions to Bidders.

Bid opening shall be held on 28 February 2017 at 10:15 A.M. at the CSA Conference Room, 2<sup>nd</sup> Floor, TESDA Administration Building, Taguig City where the bids will be opened in the presence of the Bidders' representatives. Late bids shall not be accepted.

All particulars relative to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bid Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of Republic Act No. 9184 and its Revised Implementing Rules and Regulations.

The TESDA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of Republic Act No. 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
