## MEMORANDUM OF AGREEMENT

S MEMORANDUM OF AGREEMENT is made and entered into this 2017 by and between:

The **TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY** (TESDA), a national government agency created and existing under and by virtue of Republic Act No. 7796 with principal address at TESDA Complex, East Service Road, South Luzon Expressway, Taguig City, Metro Manila, Philippines, represented herein by its Director General/Secretary, GUILING A. MAMONDIONG and hereinafter referred to as the "FIRST PARTY";

- and -

TUV SUD PSB PHILIPPINES INC., a private business entity, registered under the laws of the Republic of the Philippines with business address at Unit 1808, The Orient Square Building, F. Ortigas Jr. Road, Ortigas Center, Pasig City, herein represented by its General Manager, **MS. FEMELYN S. LATI**, and hereinafter referred to as the "SECOND PARTY".

WITNESSETH -

WHEREAS, the FIRST PARTY through its Bids and Awards Committee (BAC) issued and posted a Request for Expression of Interest in in two (2) newspapers of general circulation namely the Philippine Star and the Philippine Daily Inquirer and in the Philippine Government Electronic Procurement System (PhilGEPS) on 02 August 2017 in compliance with Section 21 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, for the Procurement of Certification Services for ISO 9001:2015 Re-Certification / Upgrading – Re-Bidding;

WHEREAS, during the submission of eligibility documents, only TUV SUD PSB Philippines Inc. passed the preliminary eligibility requirements and was short listed;

WHEREAS, upon careful examination, validation and verification of all the technical and financial proposals submitted by the SECOND PARTY, the bid of the SECOND PARTY amounting to One Million Seven Hundred Twenty Thousand Eight Hundred Eighty Pesos (Php1,720,880.00) has satisfactorily passed the legal, financial and technical requirements set forth by Republic Act No. 9184 and the bidding documents;

WHEREAS, after post-qualification prescribed by Section 34 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the bid offered by the SECOND PARTY has been found to be the highest rated responsive bid;

**NOW, THEREFORE**, for and in consideration of the foregoing, this Agreement is entered by and between the **FIRST PARTY** and the **SECOND PARTY** with the following covenants, to wit:

Moreover, the details of the activities, deliverables and timelines are specified in the attached GANNT chart hereto attached as Annex "A" and shall become an integral part of this Agreement.

- C. The expected outputs of the SECOND PARTY shall be as follows:
  - 1. Certification Audit and Surveillance Audit Plans and Audit Schedules;
  - 2. Certification Audits, Stage I and Stage II conducted;
  - 3. Audit Reports for Stage I and Stage II;
  - 4. Surveillance conducted during the 3-year period;
  - 5. Surveillance Audit Reports; and
  - ISO 9001:2015 main certificate which shall be awarded to TESDA Central Office and sub-certificates which shall be issued to the other one hundred four (104) audit sites covered.
- D. The FIRST PARTY shall:
  - Provide furnished working space for the SECOND PARTY during the audit period;
  - Provide access and use of the facilities necessary for the rendition of services of the SECOND PARTY; and
  - Provide funding for payment of the services rendered by the SECOND PARTY subject to the government accounting and auditing rules and regulations.

# Section II

## TERMS AND CONSIDERATIONS

The FIRST PARTY shall pay the SECOND PARTY the amount of **One Million Seven Hundred Twenty Thousand Eight Hundred Eighty Pesos (Php1,720,880.00)** for the actual services rendered by the SECOND PARTY, chargeable against Fund 101, subject to the following:

Payment shall only take effect after actual rendition of the services as herein prescribed and acceptance by the FIRST PARTY of the output of the SECOND PARTY is made subject to government accounting and auditing rules and regulations.

# Section IV AMENDMENT CLAUSE

No amendment, modification, or alteration of this Agreement shall be valid and binding on either Party unless expressed in writing and executed with the same formalities observed in this Agreement.

# Section V EFFECTIVITY

This Agreement shall be valid and effective upon signing of the Parties and may be terminated by either party subject to written notification to the other Party within thirty (30) calendar days prior to the intended date of termination subject to whatever obligations already incurred.
