In view of the need to make the PGMA-TWSP LEP more responsive and attuned to the needs of the target clienteles, the following amendments to the Implementing Guidelines on the PGMA-TWSP LEP Scholarship Program are hereby formulated:

- a) Under E. Application and Selection Process, number 5) a) is hereby amended as follows:
- 5) The scholarship certificate shall be used for:
 - a) Supporting the scholar to at least finish his/her first TVET qualification, in the ladderized degree program. Preference shall be given to freshmen (fresh intakes to college). The permutation table below shall guide the payment of tuition subsidies to the HEI/SUC.

Under H. PAYMENT, item no. 2 is amended as follows:

- 2) The Regional Directors shall pay the training institution within fifteen (15) working days from the date of the HEI/SUC submission of the following, subject to government accounting and auditing rules and regulations:
 - a) For scholars who will take only one semester/summer term to finish a TVET qualification as indicated in the ladderized curriculum
 - TESDA copy of the scholarship certificate with the back portion of the certificate, complete with required signatories including authorized signatories of the HEI/SUC;
 - ii. Billing statement:

³ The P5,000 is given only once in the 2nd semester/summer of the first year for scholars accepted that will only take one term to exit a TVET qualification.

⁴ The P5,000 is given only once in any of the semesters of the second year for scholars accepted that will only take one term to exit a TVET qualification.

² Start of payment is on the term of effectivity of the scholarship and in no way should be retroactive. First TVET exit point beyond 2nd semester of the 2nd year shall not be anymore entitled to financial subsidy.

- iii. Enrolment report; and
- iv. Terminal report (first TVET exit point);
- v. The financial assistance for this last term shall be paid within fifteen (15) working days upon submission of the mentioned documents by the school.
- vi. Any student who drops out before the end of the semester/summer term forfeits his/her right to financial subsidy.
- b) For scholars who will take more than one semester to finish a TVET qualification:
 - TESDA copy of the scholarship certificate with the back portion of the certificate, complete with required signatories including authorized signatories of the HEI/SUC (only in the first instance);
 - ii. Billing statement every semester and summer (if applicable) until the scholar finished the first TVET qualification;
 - iii. Certificate of enrolment every semester and summer (if applicable) until the first TVET qualification is finished;
 - iv. Enrolment report every semester and summer (if applicable) until the first TVET qualification is finished.
 - v. Amount of payment shall correspond to the permutation tables indicated above. Payments shall be released to the school within fifteen (15) working days upon submission of the above documents.
 - vi. Any student who drops out before the end of the semester/summer term forfeits his/her right to financial subsidy.

These amendments shall revoke the identified sections of TESDA Circular No. 49, s. 2006 and shall remain in force until superseded. Other provisions of the said Circular not covered by these amendments shall remain valid and in force.
