DESIGNATION OF COMMITTEE CHAIRPERSONS AND CO-CHAIRPERSONS





WHEREAS, Section 46 of the Manual of Internal Rules of Procedures of the TESDA Board provides that there shall be an open membership to the TESDA Board Committees and further states that the Chairperson and Co-Chairperson of Standing Committees shall be nominated and must be approved by a meeting duly convened for such purpose;
