A. Two (2) Government Sector Representatives

- One (1) Local Government Representative and
- One (1) other Representative from a line Agency relevant to the nature of school

B. Two (2) Industry/Employer Sector Representatives one of whom shall be Chairman.

- One (1) Business Sector Representative
- One (1) Major Representative in Industry/Business Sector in the area

C. One (1) Non Government Organization/Peoples Organization Representative

D. One (1) Worker Union Representative

E. Center/ School Head as voting member and Vice Chairman
