**Approval And Award Of Civil Works Contracts For
Construction/Rehabilitation/Refurbishment Of Centexes Under The Technical
Education And Skills Development Project (TESDP) Fund 102**

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994", grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, in the Second Foreign Assisted Projects (FAPs) Committee Meeting of the TESDA Board held last 14 November 2003, and in accordance with the ADB and TESDA internal guidelines it was recommended that the proposed civil works contracts for construction/rehabilitation/refurbishment of centexes with the amount above the Approved Budget for Contract (ABC) shall be re-bid in FY2004 using the FY2003 continuing appropriation cover. The proposed contracts after re-bidding were as follows:


