**Approval and Award of Contract for the Youth Profiling for Starring Careers (YP4SC)
Instrument and Testing Services to Profiles Asia Pacific**

WHEREAS, Section 2 of Republic Act No. 7796, otherwise known as the Technical Education and Skills Development Authority (TESDA) Act of 1994, hereby declares that it is the policy of the State to provide relevant, accessible, high quality and efficient technical education and skills development in support of the development of high quality Filipino middle-level manpower responsive to and in accordance with Philippine development goals and priorities

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994", grants the TESDA Board the power to refer, to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, in the 44th TESDA Board Meeting which was held 9 December 2004, the members of the Board approved Board Resolution No. 2004-18 Adoption of the Five Essential Paradigm Shifts;

WHEREAS, paradigm shift No. 1 Pro-active Job Skills Matching Process states that

*We **SEEK jobs** through domestic and international market intelligence to pinpoint exact requirements for the job vacancies*

*We **FIND people** who can fit the available jobs*

*We **TRAIN people** using standards of quality of technical and vocational education and training for best fit to jobs. As a necessary component of the matching process, the **YP4SC (YOUTH PROFILE FOR STARRING CAREERS)** will provide guidance to the youth and their parents to select programs suitable for a 'STAR' profile*




