**WHEREAS**, the TESDA Board passed and adopted TESDA Board Resolution No. 2005-05 "Approving The Manual Of TESDA Policies and Procedures On Procurement" during its 46<sup>th</sup> Board Meeting last May 19, 2005;

**WHEREAS**, prior to the attestation of the Board Resolution by the Chair, a final staff review to further enhance the Manual was conducted and several comments/recommendations, a copy of which is appended as Annex A, were forwarded to the Secretariat as contained in a Memorandum dated June 17, 2005 signed by Undersecretary Danilo P. Cruz of the Department of Labor and Employment;

**WHEREAS**, acting on said comments/recommendations, the TESDA Secretariat resubmitted on July 15, 2005 the revised Manual to the Office of the Chair incorporating the revisions herein referred to as Annex B;

**WHEREAS**, the Board, during its 47<sup>th</sup> Board Meeting last August 4, 2005, recognizing the revisions made on the previously approved Manual, deemed it necessary to issue an amendatory resolution to that effect;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the Board approves the amendments to TESDA Board Resolution No. 2005-05 to be officially referred hereto as the **Manual Of TESDA Policies And Procedures On Procurement Revised as of August 4, 2005**;

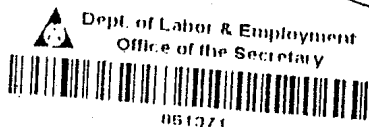
