WHEREAS, during the 46th TESDA Board Meeting held last 19 May 2005 TESDA Board Resolution No. 2005-09 "Prioritization of the Thirty Five (35) Qualifications for the Development of Training Regulations for Year 2005" was approved and adopted;

WHEREAS, during the 47th TESDA Board Meeting held last 4 August 2005 the Board approved TESDA Board Resolution No. 2005-14 "Prioritization of additional four (4) Qualifications for the Development of Training Regulations for Year 2005 (Masonry NCI, Jewelry Making NCII, Fish Capture NCII and Agri-Crops Production NCII)";

WHEREAS, the Board approved a total of thirty nine (39) priority qualifications under the Philippine TVET Qualifications Framework (PTQF) and hereby directed the TESDA Secretariat to undertake the development of training regulations;

WHEREAS, in the 10th and 11th Standard Setting and Systems Development (SSSD)-TESDA Board and TESDA Secretariat Consultation meetings held last 18 July 2005, and 23 July 2005, respectively, the Training Regulations formulated for PC Operations NCII (IT User), Animation NCIII, and Programming NCIV were presented and deliberated.

BE IT RESOLVED FINALLY, that copies of the Resolution and Training Regulations (TR) be published and disseminated to all concerned and shall be effective fifteen (15) days upon its publication. All training programs under these training regulations must comply with the requirements of the abovementioned TRs. Graduates of TVET courses covered by the abovementioned training regulations shall be required to undergo mandatory assessment under the national assessment and certification system.
