PRIORITIZATION OF THE SIXTY TWO (62) QUALIFICATIONS FOR THE DEVELOPMENT OF TRAINING REGULATIONS FOR YEAR 2006

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the TESDA Board has promulgated training regulations in TESDA Board Resolution Nos. 2004-01, 2004-02, 2004-20, 2004-21, 2005-03, 2005-10 and 2005-15;

WHEREAS, the Board realizes that while priorities should be focused on the most critical levels of TVET qualifications, program regulation would be more comprehensive if training regulations are promulgated for all possible National Certificate levels;

NOW THEREFORE BE IT RESOLVED AS IT IS RESOLVED that the following qualifications be included in the priority list of training regulations to be developed in 2006;



BE IT RESOLVED, FURTHER, that other emerging critical skills not herein included may be developed to quickly respond to labor market demands;


BE IT RESOLVED, FURTHER, that the training regulation development for the above qualification strictly follow the established procedure and extensive industry participation;


BE IT RESOLVED FINALLY, that the Secretariat provide the necessary resources to achieve the objectives of this resolution.
