**Expanding the List of Training Regulations for Development in Response to  
Executive Order No. 358 (To Institutionalize a Ladderized Interface between Technical  
Vocational Education and Training (TVET) and Higher Education (HE))**

**WHEREAS**, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

**WHEREAS**, Executive Order No. 358 - To Institutionalize a Ladderized Interface between Technical Vocational Education and Training (TVET) and Higher Education (HE) was approved by President Gloria Macapagal Arroyo 15 September 2005;

**WHEREAS**, the TESDA Board has promulgated training regulations in TESDA Board Resolution Nos. 2004-01, 2004-02, 2004-20, 2004-21, 2005-03, 2005-10 and 2005-15;

**WHEREAS**, the growth and development of the economy and the dynamism of local and global labor markets necessitate quick responses in terms of training regulations for emerging training and competency certification requirements;

**WHEREAS**, the Board realizes that while priorities shall be focused on the most critical levels of TVET qualifications, training regulations would be more comprehensive and promulgated for all possible National Certificate levels per occupation;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, that the Secretariat be authorized to work with industry associations and industry working groups to identify qualifications in various levels and develop training regulations thereof in agriculture, tourism, health care, Information and communications technology, maritime and security services, education and engineering that shall respond to the emerging training needs and competency certification requirements and submit these to the TESDA Board thru the Standard Setting and Systems Development Committee for promulgation ;


**BE IT RESOLVED, FURTHER,** that the training regulations development for the above qualification strictly to follow the established procedure and extensive industry participation;


**BE IT RESOLVED FINALLY,** that the Secretariat provide the necessary resources to achieve the objectives of this resolution.
