APPROVING THE AMENDMENTS OF BOARD RESOLUTION NO. 2001-01 DEFINING THE POWER OF THE CHAIRPERSON OF THE TESDA BOARD AND THE DIRECTOR GENERAL OF THE TESDA SECRETARIAT TO ENTER INTO, MAKE AND EXECUTE DOMESTIC AND FOREIGN CONTRACTS IN BEHALF OF THE TESDA BOARD

WHEREAS, TESDA Board Resolution No. 2001-01 has authorized the Chairperson of the TESDA Board and the Director General of the TESDA Secretariat to enter into, make and execute, for and in behalf of the TESDA Board, domestic contracts in the following amounts:

- a. For the Director General for all amounts up to **Two (2) Million Pesos** which may be further delegated to sub-national levels, and
- b. For the Chairperson of the TESDA Board for amounts up to **Five (5) Million Pesos**.

WHEREAS, in a meeting between the Chairperson and the Director General, the Alternate Chairperson on 30 January 2006, the Chairperson urged the TESDA Board to vest on the Alternate Chairperson the same level of signing authority of the Chairperson.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board amends TESDA Board resolution No. 2001-01 to vest on the Alternate Chairperson the same signing authority of the Chairperson, TESDA Board






