APPROVING OCCUPATIONS/QUALIFICATIONS WITH PROMULGATED TRAINING REGULATIONS AS APPRENTICEABLE OR LEARNABLE OCCUPATIONS ENDORSED BY INDUSTRY WORKING BODIES AND OTHER RECOGNIZED INDUSTRY BODIES

WHEREAS, Section 3(b) of R.A. 7796 provides that it is the goal and objective of the Act to focus technical education and skills development on meeting the changing demands for quality middle level manpower;

WHEREAS, Section 18 of R.A. 7796 provides the transfer of the Apprenticeship Program of the Bureau of Local Employment to Technical Education and Skills Development Authority (TESDA) which shall implement and administer said programs in accordance with existing laws, rules and regulations;

WHEREAS, the TESDA is moving towards competency-based training, standards and assessment as part of its package of reforms towards quality-assured technical and vocational education and training (TVET);

WHEREAS, the "Kasanayan at Hanapbuhay Program" (An Apprenticeship and Employment Program) launched in August 23, 2004, aims to provide a mechanism that shall ensure the availability of qualified workers based on industry needs and requirements, as well as facilitate and speed up the matching of jobseekers with available jobs;

WHEREAS, the current list of apprenticeable occupations has to be expanded to respond to the need of providing skills to enhance the employability of the labor force and contributing to the government's thrusts of generating 6-10 million jobs;
