WHEREAS, in consideration of two (2) failed bidding, and pursuant to Section 53 of R.A. No. 9184, the BAC deemed it proper to recommend to the Head of Procuring Entity to pursue the negotiated procurement approach to acquire/purchase the required goods and equipment indicated therein;

WHEREAS, as per BAC Resolution No. 07-05, TESDA entered into a negotiation with DESMI Contracting A/S as the sole bidder for Lots 6a and 8 in the second failed bidding;

WHEREAS, DESMI Contracting A/S has accepted TESDA's request to change the offer of re-conditioned items to BRAND NEW equipment and to adjust its bid proposals within the ABC in order for both tender proposals to be financially compliant; to wit:
