WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994", grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, TESDA is a government agency mandated to ensure provision of quality technical education and skills development for immediate employment of the Filipino workforce;

WHEREAS, part of the PGMA Training for Work Scholarship Program is to open doors for job applicants in the business process outsourcing industry;

WHEREAS, to screen the job applicants for call centers, a free testing for the first 50,000 applicants shall be provided by TESDA to identify those who are "hireable" to be immediately referred to waiting jobs in call centers and "near hires" to be immediately referred for training in the 100-Hours English Proficiency Course in TESDA-registered

WHEREAS, to undertake the task of screening applicants for call center jobs, there is a need for a costeffective, accessible and fast screening instrument that can be used by all | ESDA field operating units;

WHEREAS, it is deemed necessary to procure the test instrument from a technically and financially experienced supplier;

WHEREAS, under Section 50 of the Implementing Rules and Regulations-A of Republic Act No. 9184, the Authority is empowered to procure goods and services from an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute items of proprietary nature can be obtained at more advantageous terms to the Government through Direct Contracting which only requires the procuring entity to simply ask the supplier to submit a price quotation or a pro-forma invoice topether with the conditions of sale;
