WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994", grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing law, rules and regulations.

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA)

WHEREAS, the Authority in keeping with its mandate; engaged itself in the continuous formulation of policies, design in implementing TVET programs; updating and continuous improvement of TVET curriculum; trainers capability build-up; provisions of new and adequate learning materials to cope with the emerging industry needs;

WHEREAS, the learning materials or book series entitled Career Guidance In Ladderized Education For Filipino Empowerment (The Beginning Manual) Salabat For The Filipino Soul Book 2 was developed to equip TVET students and graduates with a layman's understanding of TESDA's programs and projects, at the same time, enhancement of their moral values;

WHEREAS, the book development, manuscript, preparation, lay-out and other publication-related activities is handled by the TESDA Consultant for research and editorial services under the direct supervision of the Director General,

WHEREAS, subject learning material is ready for printing and expected to be distributed among TVET students, partners and stakeholders nationwide;




