**APPROVING THE AMENDMENTS ON THE TRAINING REGULATIONS FOR  
MEDICAL TRANSCRIPTION NCII**

**WHEREAS**, Board Resolution No. 2004-02 Approving and Adopting the Training Regulations for the Information and Communication Technology (ICT) Sector- Medical Transcription was promulgated by the TESDA Board during 41<sup>st</sup> TESDA Board Meeting which was held last 5 February 2004;

**WHEREAS**, the Education Committee of the Medical Transcription Industry Association of the Philippines, Inc. (MTIAPI) /Technical Experts have endorsed the amendments on the Training Regulations for Medical Transcription NCII (Training Standards with respect to trainee entry requirements, list of tools, equipment and materials, training facilities; trainers qualification and institutional assessment and Acknowledgement)

**WHEREAS**, during 17<sup>th</sup> Standard Setting and Systems Development TESDA Board- TESDA Secretariat Consultation Meeting, 26 September 2006 the amendments to the Training Regulations for Medical Transcription NCII (Training Standards and Acknowledgement) were deliberated and favorably recommended to the TESDA Board for approval;

**WHEREAS**, during the 46<sup>th</sup> Executive Committee- TESDA Board Meeting held on 19 October 2006, the results of the deliberation on the amendments of the Training Regulations for Medical Transcription NCII was presented and favorably endorsed for consideration and approval of the TESDA Board;

**NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the Board approves the aforementioned amendments to the training regulations;




**APPROVING THE AMENDMENTS ON THE TRAINING REGULATIONS FOR

All programs under these amended training regulations must comply with the requirements of the aforementioned TRs. Graduates of TVET courses covered by the aforementioned training regulations shall be required to undergo mandatory assessment under the national assessment and certification system.
