Approving the Award of Contract to AT & E TECHNICAL, INC. for the Electrical Rehabilitation of  
NITVET/OTI Facilities amounting to Php14,781,312.66

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing law, rules and regulations.

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the Philippine Government has received a loan for international development from ADB and OPEC for the electrical rehabilitation of NITVET/OTI Facilities;

WHEREAS, in the 19th Finance TESDA Board and TESDA Secretariat Consultation Meeting held on 10 October 2006, the TESDA Secretariat through Bids and Awards Committee recommended for approval the proposed Electrical Rehabilitation of NITVET/OTI Facilities.

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements, the Technical Working Group submitted its recommendation that AT & E Technical Services, Inc. could finish the project without difficulty, being legally, financially and technically competent.
