**APPROVING THE AMENDMENTS ON THE TRAINING REGULATIONS FOR
SHIELDED-METAL ARC WELDING (SMAW) NCII**

WHEREAS, Board Resolution No. 2004-20 Approving and Adopting the Training Regulations for Welding NCII was promulgated by the TESDA Board during the 44th TESDA Board Meeting which was held last 09 December 2004;

WHEREAS, during the 21st Standard Setting and Systems Development (SSSD) TESDA Board-TESDA Secretariat Consultation Meeting, 12 December 2006, it was agreed that the Training Regulations for Welding NCII promulgated in Y2004 be amended by deleting the provision for Gas Tungsten Arc Welding (GTAW), and adopting the training regulation for Shielded-Metal Arc Welding (SMAW) NCII;

WHEREAS, during the 53rd TESDA Board Meeting held on 14 December 2006, the TESDA Board agreed and approved the Training Regulations for Shielded-Metal Arc Welding (SMAW) NCII;


NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board approves the aforementioned amendments to the training regulations, as attached;

BE IT RESOLVED FINALLY, that copies of the Resolution and amended copies of the Training Regulations (TRs) for Shielded-Metal Arc Welding (SMAW) NCII be published and disseminated to all concerned, and shall be effective fifteen (15) days upon its publication. All programs under these amended training regulations must comply with the requirements of the aforementioned TRs. Graduates of TVET courses covered by the aforementioned training regulations shall be required to undergo mandatory assessment under the national assessment and certification system.
