**APPROVING THE AMENDMENT TO BOARD RESOLUTION NO. 2006-27 APPROVING THE AWARD OF CONTRACT TO AT & E TECHNICAL, INC. FOR THE ELECTRICAL REHABILITATION OF NITVET/OTI FACILITIES AMOUNTING TO PHP14,781, 312.66 ON THE AUTHORIZATION OF DR. AUGUSTO BOBOY SYJUCO AS THE ALTERNATE CHAIR OF THE TESDA BOARD AND SECRETARY/DIRECTOR GENERAL OF TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) TO SIGN THE FINAL TERMS AND CONDITIONS OF THE CONTRACT IN BEHALF OF TESDA BOARD**

**WHEREAS**, Section 8, paragraph 3 of Republic Act No. 7796, otherwise known as the "Technical Education and Skills Development Act of 1994", grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts, subject to existing law, rules and regulations;

**WHEREAS**, in the exercise of this power, the TESDA Board shall approve all contracts, both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

**WHEREAS**, in the 52<sup>nd</sup> TESDA Board Meeting held 26 October 2006, the Board approved Board Resolution No. 2006-27 "Approving the Award of Contract to AT & E TECHNICAL, INC. for the Electrical Rehabilitation of NITVET/OTI Facilities amounting to Php14,781,312.66";


