APPROVING THE AMENDMENTS ON THE TRAINING REGULATIONS FOR CAREGIVING NCII

WHEREAS, Board Resolution No. 2003-01 "Approving and Adopting the Training Regulations for the Caregiving" was promulgated by the TESDA Board through the TESDA Board Referendum dated 10 January 2003, and Board Resolution No. 2004-21 "Authorizing the Publication of the Reformatted Training Regulations for Caregiving NCII" during the 44th TESDA Board Meeting which was held last December 9, 2004;

WHEREAS, to support and address the urgency of supplying the demand for workers by employers both in the local and overseas market for caregivers, there is a need to amend Section-4 National Assessment and Certification Arrangements of the said Training Regulations to include assessment of individuals along competencies for specific types of clients;

WHEREAS, the qualifications of the Caregiving NCII may be attained through 1) the demonstration of all units of competency through project-type assessment leading to a full National Certificate (NC), or 2) the accumulation of Certificates of Competency (COCs) in the following areas: a) providing care and support for infants, toddlers and children, and b) providing care and support for the elderly and people with special needs both areas of which will include the household service competencies;

WHEREAS, during the First Joint Standard Setting and Systems Development (SSSD) and Finance TESDA Board and TESDA Secretariat Consultation Meeting held on 15 January 2007, the amendments to the Training Regulations for Caregiving NCII (Section-4 National Assessment and Certification Arrangements to include *assessment of individuals along specific units of Competency (COCs), providing care and support for infants, toddlers and children; providing care and support for elderly and people with special needs; and demonstration of competence through project-type assessment covering all required units of qualification*) were presented and deliberated on;

WHEREAS, during the First Joint Standard Setting and Systems Development (SSSD) and Finance TESDA Board and TESDA Secretariat Consultation Meeting held on 15 January 2007, the committee agreed to recommend the amendments on the Training Regulations for Caregiving NCII;



APPROVING THE AMENDMENTS ON THE TRAINING REGULATIONS FOR CAREGIVING NCII



All programs under these amended training regulations must comply with the requirements of the aforementioned TRs. There shall be mandatory national assessment required for graduates of TVET courses covered by this TR.
