**Amending Training Regulations for Household Services NCII to include Portfolio
Assessment as Method of Assessment for HS NCII**

WHEREAS, Board Resolution No. 2005-10 Approving and Promulgating the Training Regulations for Household Services NCII was approved by the TESDA Board during the 46th TESDA Board Meeting which was held last 19 May 2005;

WHEREAS, TESDA recognizes and support, the principles of Competency-Based Training, Assessment and Certification and Recognition of Prior Learning;

WHEREAS, there is a need to support and address the issue that returning household service workers need not undergo the usual assessment process because of their accumulated experiences working overseas as household workers;

WHEREAS, with the inclusion of the portfolio method of assessment, experienced household workers would be able to facilitate and fast-track processing of their papers in the event of immediate hiring for employment;

WHEREAS, in order to establish acceptable and updated Training Regulations for Household Services NCII, an amendment to the Methods of Assessment under the Evidence Guide for all core units of competency is hereby made to include Portfolio Assessment;

WHEREAS, during the 2nd Joint Standard Setting and Systems Development and Finance TESDA Board and TESDA Secretariat Consultation Meeting, the members of the SSSD and Finance Committee - TESDA Board favorably endorsed for consideration and approval of the Board the amendment of Section 3 of BR No. 2005-10 of Training Regulations Household Services NCII;
