APPROVING THE IMPLEMENTING GUIDELINES ON THE RECOGNITION OF NATIONAL INDUSTRY BODIES (RNIBs)

WHEREAS, Section 26 of the TESDA Law provides that TESDA shall establish effective and efficient institutional arrangements with industry boards and such other bodies or associations to provide direct participation of employers and workers in the design and implementation of skills development schemes, trade skills standardization and certification and such other functions in the fulfillment of the Authority's objectives;

WHEREAS, during the 42nd TESDA Board Meeting held last 06 May 2004 the TESDA Board approved TESDA Board Resolution No. 2004-06 "Approving the Establishment and Operationalization of Industry Working Groups (IWGs) for Technical Education and Skills Development in Four (4) Identified Priority Sectors (Health, Tourism, Information and Communication Technology and Agri-Fishery) in an Experimental Basis";

WHEREAS, during the Support to TVET Provision TESDA Board-TESDA Secretariat Consultation Meeting held last 04 May 2007, the draft copy of the Implementing Guidelines on the Recognition of National Industry Bodies (RNIBs) was presented to and considered by the Committee with the condition that all issues raised during the said Committee Meetings shall be complied by the TESDA Secretariat (TSDO);

WHEREAS, to implement the aforementioned provisions TESDA shall recognize National Industry Bodies that shall serve as the technical advisory group of TESDA skills in various areas such as but not limited to planning, standards development, assessment and certification and program registration among others,

WHEREAS, the Recognized National Industry Bodies (RNIBs) shall perform the following functions;

1. provide advice to the TESDA Board in the identification of industry skills development and training needs based on consultation with the local industry bodies;
2. develop the sectors' national skills plan
3. develop, regularly review and update competency standards, curriculum exemplars and assessment tools in cooperation with TESDA; and
4. actively participate in the promotion and implementation of various Technical Vocational Education and Training (TVET) activities such as but not limited to skills planning; development of competency standards; curriculum exemplars and assessment tools; assessment and certification; and program registration and certification.


