WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification systems in the country;

WHEREAS, the concerned Technical Expert Panel (Construction Sector) has endorsed for promulgation the aforementioned Training Regulations;

WHEREAS, during the 24TH Standard Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting held last 16 July 2007 the aforementioned Training Regulations was deliberated and favorably recommended to the EXCOM-TESDA Board for consideration and approval;

WHEREAS, during the 50th EXCOM-TESDA Board Meeting held on 17 July 2007 the EXCOM-TESDA Board endorsed favorably the aforementioned Training Regulations for consideration and approval of the TESDA Board;

WHEREAS, in the 56th TESDA Board Meeting held on 27 July 2007 the TESDA Board members considered and approved the aforementioned Training Regulations;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board approves and promulgates the Training Regulations for Scaffold Erection NCII, Reinforced Steel Bar Installation NCII, and Tile Setting NCII;


**APPROVING AND PROMULGATING THE TRAINING REGULATIONS
