WHEREAS, during the 24^{th} Standard Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting held last July 16, 2007, further deliberation led to an agreement to recommend the promulgation of Animation NCII, 2D Animation NCIII, and 3D Animation NCIII separately and supersede the Training Regulation for Animation NC III promulgated through Board Resolution 2005 – 19.

WHEREAS, during the 50th EXCOM-TESDA Board Meeting held on 17 July 2007 the promulgation of training regulations for Animation NCII, 2D Animation NCIII, and 3D Animation NCIII were endorsed favorably for consideration and approval of the TESDA Board;
