**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR PEST
MANAGEMENT (VEGETABLE) NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the concerned Industry Working Group (Agriculture and Fishery Sector) has endorsed for promulgation the aforementioned Training Regulation;

WHEREAS, in the 23rd Standard Setting and Systems Development-TESDA Board- TESDA Secretariat Consultation Meeting held last June 26, 2007 the aforementioned Training Regulation was deliberated and favorably recommended to the EXCOM- TESDA Board for consideration and approval;

WHEREAS, in the 48th EXCOM- TESDA Board Meeting held on 27 June 2007 the EXCOM- TESDA Board endorsed favorably the aforementioned Training Regulation for consideration and approval of the TESDA Board;

WHEREAS, in the 56th TESDA Board Meeting held on 27 July 2007, the TESDA Board considered and approved the training regulation for Pest Management (Vegetable) NCII;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Board approves and promulgates the Training Regulation for Pest Management (Vegetable) NCII;




**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR PEST
MANAGEMENT (VEGETABLE) NCII**
