**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR FISH
PRODUCTS PACKAGING NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the concerned Industry Working Group (Processed Food and Beverage Sector) has endorsed for promulgation the aforementioned Training Regulations;

WHEREAS, in the 23rd Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last June 26, 2007 the aforementioned Training Regulation were deliberated and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, in the 48th EXCOM-TESDA Board Meeting held on 27 June 2007 the EXCOM-TESDA Board endorsed favorably the aforementioned Training Regulation for consideration and approval of the TESDA Board;

WHEREAS, in the 56th TESDA Board Meeting held on 27 July 2007 the TESDA Board considered and approved Training Regulation for Fish products Packaging NCII;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED,
that the Board approves and promulgates the Training Regulation for Fish Products Packaging NCII;




**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR FISH
PRODUCTS PACKAGING NCII**

BE IT RESOLVED FINALLY, that copies of the resolution and Training Regulations (TRs) be published and disseminated to all concerned and shall be effective fifteen (15) days upon its publication. All programs registered under or to be under these training regulations must comply with the requirements of the aforementioned training regulations. Graduates of TVET courses covered by the aforementioned training regulations shall be required to undergo mandatory assessment under the national assessment and certification system.
