**WHEREAS**, Section 8, paragraph 9 of Republic Act No. 7796 or the Technical Education and Skills Development Act of 1994 empowers the TESDA Board to "exact reasonable fees and charges for such tests and training conducted and retain such earnings for its own use, subject to guidelines promulgated by the Authority;"

**WHEREAS**, in the General Directorate Conference last November 2004 and Administrators Conference, September 2006 consultations were done to rationalize and standardized the fees collected by the TESDA Technology Institutions.

**WHEREAS**, in the 49<sup>th</sup> EXCOM TESDA Board Meeting, 27 June 2007 and 23<sup>rd</sup> Finance TESDA Board and TESDA Secretariat Consultation Meeting, 10 July 2007 the TESDA Secretariat recommended for endorsement to the TESDA Board the adoption and promulgation of the standard fee structure for the TESDA Technology Institutions;

**WHEREAS**, in the 50<sup>th</sup> EXCOM-TESDA Board Meeting held last 17 July 2007, the TESDA Board endorsed favorably for NEDA Board consideration and approval the adoption and promulgation of the standard fee structure for the TESDA Technology Institutions;




