WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry-out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign, entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the TESDA Secretariat through the Bids and Awards Committee recommended for approval the award of contract for Lot No. 2 (Metals and Engineering) to State Alliance Enterprises, Inc. as the bidder with the lowest calculated responsive bid for the procurement of various testing and training equipment under NDFTES-02, subject however to a condition that the awarded bidder should be one hundred percent (100%) technically and financially compliant;


