WHEREAS, the concerned Industry Working Group (Philippine Chamber of Agriculture and Foods, Inc.) has endorsed for promulgation the aforementioned Training Regulation for Fishport/wharf Operations NCI;

WHEREAS, in the 23rd Standard Setting and Systems Development–TESDA Board-TESDA Secretariat Consultation Meeting held last 26 June 2007, the aforementioned Training Regulation was deliberated upon and it was suggested to further review the competency map of the Fishport/Wharf Operations NCI because it includes competencies along Construction and Shipbuilding such as dry docking operations, carpentry works, motor pool operations and logistic operations;

WHEREAS, in the 25th Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last 05 September, 2007 the competencies of unload and load fish products, and classify fish and fish products in the competency map for Fish Capture Operation of the aforementioned Training Regulation

WHEREAS, in the 52nd EXCOM-TESDA Board Meeting held on 30 October, 2007, the EXCOM-TESDA Board endorsed favorably the aforementioned training regulation for consideration and approval of the TESDA Board;
