**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR
BOOKKEEPING NCIII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 55th TESDA Board Meeting which was held last 20 April, 2007, the TESDA Board considered and approved Board Resolution No. 2007-11 the prioritization of fifty three (53) titles for training regulations development for year 2007 where photography under the visual arts sector was included;

WHEREAS, the concerned industry association (Professional Bookkeeper Association of the Philippines, Inc.) has endorsed for promulgation the aforementioned Training Regulation for Bookkeeping NCIII;

WHEREAS, in the 21st Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last 12 December, 2006 the aforementioned training regulation was presented and was recommended by the TESDA Board to include in the Y2007 Priority Qualifications for the Development of Training Regulations;

WHEREAS, in the 25th Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last 05 September, 2007 the aforementioned training regulation was deliberated and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, in the 52nd EXCOM-TESDA Board Meeting held on 30 October, 2007 the EXCOM-TESDA Board endorsed favorably the aforementioned training regulation for consideration and approval of the TESDA Board;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 22 November, 2007 approves the Training Regulation for Bookkeeping NCIII.


**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR
BOOKKEEPING NCIII**

BE IT RESOLVED FINALLY, that copies of the resolution and Training Regulations (TRs) be published and disseminated to all concerned and shall be effective fifteen (15) days upon its publication. All programs registered under or to be under these training regulations must comply with the requirements of the aforementioned training regulations. Graduates of TVET courses covered by the aforementioned training regulations shall be required to undergo mandatory assessment under the national assessment and certification system.
