Heavy Equipment Operation (Paver) NCII, and Heavy Equipment Operation (Rigid Off-Highway Dump Truck) NCII were included;

WHEREAS, in the 22<sup>nd</sup> Standard Setting and Systems Development–TESDA Board-TESDA Secretariat Consultation Meeting held last 18 April, 2007 the committee agreed to consider the reconfiguration of the existing packaging rule for the qualifications in Heavy Equipment Operation NCII wherein the operator is required to operate three (3) heavy equipments;

WHEREAS, in the 22<sup>nd</sup> Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last 18 April, 2007 the decision made was to award a National Certificate (NC) if an operator is competent to operate one (1) heavy equipment (one machine - one qualification);

**WHEREAS**, in the 25<sup>th</sup> Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last 05 September, 2007 the aforementioned training regulations were deliberated on and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, in the 52<sup>nd</sup> EXCOM-TESDA Board Meeting held on 30 October 2007 the EXCOM-TESDA Board endorsed favorably the aforementioned Training Regulations for consideration and approval by the TESDA Board;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 22 November, 2007 approves the Training Regulations for Heavy Equipment Operation (Transit Mixer) NCII, Heavy Equipment Operation (Rigging) NCI, Heavy Equipment Operation (Concrete Pump) NCII, Heavy Equipment Operation (Road Roller) NCII, Heavy Equipment Operation (Articulated Off-Highway Dump Truck) NCII, Heavy Equipment Operation (Paver) NCII, and Heavy Equipment Operation (Rigid Off-Highway Dump Truck) NCII.
