**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
HOUSEKEEPING NCIII, HOUSEKEEPING NCIV, EVENTS MANAGEMENT
SERVICES NCIII, ATTRACTION AND THEME PARKS OPERATIONS NCII, AND
TOURISM PROMOTION SERVICES NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 46th TESDA Board Meeting on 10 May, 2005, the TESDA Board approved Board Resolution No. 2005-09 prioritizing thirty five (35) qualifications which included the five (5) qualifications for the Tourism Sector-Events Management Services NCII, Sales/Office Operations NCII, Attractions and Theme Parks Operations NCII, Housekeeping NCIII and Housekeeping NCIV;

WHEREAS, the concerned Industry Working Group (Tourism Industry Board Foundation, Inc. (TIBFI)) has endorsed for promulgation the aforementioned training regulations;

WHEREAS, in the 26th Standard Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting held last 14 November, 2007 the aforementioned training regulations were deliberated and favorably recommended to the EXCOM-TESDA Board for consideration, with the qualification Sales/Office Operations to be retitled as Tourism Promotions Services NCII;

WHEREAS, during the 53rd EXCOM-TESDA Board Meeting held on 19 November, 2007 the EXCOM-TESDA Board endorsed favorably the aforementioned training regulations for consideration and approval of the TESDA Board;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 22 November, 2007 approves the Training Regulations for Housekeeping NCIII, Housekeeping NCIV, Events Management Services NCIII, Attraction & Theme Parks Operations NCII, and Tourism Promotion Services NCII.
