WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 26th Standards Setting and Systems Development – TESDA Board-TESDA Secretariat Consultation Meeting held last 14 November 2007 the body recommended to focus its efforts and resources on priority qualifications identified with partner- industry bodies and associations on the basis of:

1. Priority needs of the industry sector
2. Nationwide application in terms of public interest/welfare
3. Employment generation and investment opportunities
4. The criteria for skills standardization and certification
 - Requires education or training
 - Performance of the competency affects and endangers people's lives and limbs
 - Competency involves the handling of complex equipment, tools and supplies

WHEREAS, the National Transmission Corporation (TRANSCO) in its letter to the TESDA Secretariat dated 12 September 2007 revised the qualification standard specifically the eligibility requirement for its line workers from Republic Act (RA) 1080 (Registered Master Electrician) to TRANSCO Skills Certification Program : Electrical Transmission Lineman;

WHEREAS, the competency instrument/standard was endorsed and adopted by TESDA to support the implementation of certification by the power sector and the Skills Certification and Equivalency Program (SCEP) for government workers pursuant to the provisions of CSC Memorandum Circular No. 11s. 1996(Category I)

WHEREAS, during the 26th Standards Setting and Systems Development – TESDA Board-TESDA Secretariat Consultation Meeting held last 14 November 2007, the National Transmission Corporation (TRANSCO) recommended to the committee the retitling of the High Voltage Cable Installation Qualification To Transmission Line Installation Maintenance NCII, Transmission Line Installation and Maintenance NCII, and Transmission Line Installation and Maintenance NCIV ;


