WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the Bids and Awards Committee (BAC) as mandated by Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act" is the body tasked to post invitation to bid, conduct pre-bid conferences, determine the eligibility of prospective bidders, receive and open bids, conduct the evaluation of bids, undertake post-qualification proceedings, and recommend award of contract to the Head of the Procuring Entity;

WHEREAS, the Republic of the Philippines has received a loan from the Asian Development Bank (ADB) to implement the Technical Education and Skills Development Project (TESDP), and intends to apply part of the proceeds of said loan to payment of contract for the supply, delivery, installation and commissioning of various information and communication technology equipment, media equipment and accessories, air-conditioning units & industrial fans at an estimated project cost of Php5,703,859.00 under ADBTES-6B;

WHEREAS, the BAC, in exercising its functions and in accordance with procedures pursuant to RA No. 9184 and applicable ADB Procurement Guidelines has recommended through BAC Resolution No.057-2007 the award of contract on a per line item basis to the qualified bidder, **AYALA SYSTEMS TECHNOLOGY, INC.**;


