WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the Bids and Awards Committee (BAC) as mandated by Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act" is the body tasked to post invitation to bid, conduct pre-bid conferences, determine the eligibility of prospective bidders, receive and open bids, conduct the evaluation of bids, undertake post-qualification proceedings, and recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, the Technical Education and Skills Development Authority (TESDA), through Republic Act No. 9501, or the General Appropriations Act of FY2007 intends to apply the amount of **Php8,868,000.00** being the Approved Budget for Contract (ABC) to payment for the supply and delivery of TESDA corporate uniforms for CY2007 at Php2,000.00 per employee;

WHEREAS, the BAC, in exercising its functions and in accordance with procedures pursuant to RA No. 9184 has recommended through BAC Resolution No.068-2007 the award of contract to **SANTOYO CLOTHLINE CREATION** for the supply and delivery of TESDA corporate uniforms for CY2007 having the lowest calculated and responsive bid with a total bid of **Php7,005,720.00**;
