WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to onter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA):

WHEREAS, the Bids and Awards Committee (BAC) as mandated by Republic Act No 9184 otherwise known as the "Government Procurement Reform Act" is the body tasked to post invitation to bid, conduct pre-bid conferences, determine the eligibility of prospective bidders, receive and open bids, conduct the evaluation of bids, undertake post-qualification proceedings, and recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, the Government of the Philippines (GOP) has received a credit from the Nordic Development Fund (NDF) which form part of the Technical Education and Skills Development Project (TESDP), and has allocated a part of the loan for the procurement of testing and training equipment for various occupational sectors with a total estimated project cost of USD2,332,998.50 under NDFTES-03;

WHEREAS, a failure of bid was declared by the BAC during the first bid opening conducted last 25 April, 2007 because all qualified bidders submitted bid prices more than the estimated project cost, or an average of 248% higher and rescheduled a rebidding last 18 September, 2007;

WHEREAS, during said rebidding, again the qualified bidders submitted bid prices more than the estimated project cost, but this time much lower than the previous failed bid, prompting the BAC to continue with the proceedings on the condition that a "no objection" clause from NDF is secured authorizing reduction of quantities to more or less approximate the estimated project cost;
