APPROVING THE AWARD OF CONTRACT TO SUPERCLEAN SERVICES CORPORATION FOR THE PROVISION OF JANITORIAL SERVICES FOR CY 2008

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the Bids and Awards Committee (BAC) as mandated by Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act" is the body tasked to post invitation to bid, conduct pre-bid conferences, determine the eligibility of prospective bidders, receive and open bids, conduct the evaluation of bids, undertake post-qualification proceedings, and recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, the Technical Education and Skills Development Authority (TESDA) intends to apply the amount of **Php8,081,429.07** being the Approved Budget for the Contract (ABC) to payment for the provision of janitorial services to be charged against the FY 2008 budget for fixed costs;

WHEREAS, two (2) prospective bidders-**DEARJOHN SERVICES, INC.** with a bid price of **Php7,968,000.00** and **SUPERCLEAN SERVICES CORPORATION** with a bid price of **Php8,081,429.07** qualified in the eligibility check during the bid opening conducted by the BAC;

WHEREAS, during the evaluation and as part of post-qualification proceedings, the BAC had to disqualify **DEARJOHN SERVICES, INC.** for underpayment of SSS premiums and failure to submit an audited financial statement for FY 2006 based on documents submitted, the latter being a basic eligibility requirement;
