**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
HEAVY EQUIPMENT OPERATIONS (RIGID ON-HIGHWAY DUMP TRUCK) NCII,
HEAVY EQUIPMENT OPERATIONS (BACKHOE LOADER) NCII, HEAVY
EQUIPMENT OPERATIONS (GANTRY CRANE) NCII, HEAVY EQUIPMENT
OPERATIONS (CONTAINER STACKER) NCII, AND HEAVY EQUIPMENT
OPERATIONS (SCREED) NCI**

WHEREAS, Section 14 item (b) of RA 7796 otherwise known as the TESDA Act of 1994, mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 3rd Joint Standard Setting and Systems Development and Finance TESDA Board-TESDA Secretariat Consultation Meeting which was held last 13 March 2007, the aforementioned training regulations were deliberated upon and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, the concerned industry association (Association of Carriers & Equipment Lessors, Inc.) has endorsed for promulgation the Training Regulations for Heavy Equipment Operations (Rigid On-Highway Dump Truck) NCII, Heavy Equipment Operations (Backhoe Loader) NCII, Heavy Equipment Operations (Gantry Crane) NCII, Heavy Equipment Operations (Container Stacker) NCII, and Heavy Equipment Operations (Screed) NCI;

WHEREAS, in the 27th Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last 10 December 2007, the aforementioned training regulations were deliberated upon and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, in the 54th EXCOM-TESDA Board Meeting held last 13 December 2007 the EXCOM-TESDA Board endorsed favorably the Training Regulations for Heavy Equipment Operations (Rigid On-Highway Dump Truck) NCII, Heavy Equipment Operations (Backhoe Loader) NCII, Heavy Equipment Operations (Gantry Crane) NCII, Heavy Equipment Operations (Container Stacker) NCII, and Heavy Equipment Operations (Screed) NCI.



NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED,
that the TESDA Board in its meeting today, 19 December, 2007 approves the
Training Regulations for Heavy Equipment Operations (Rigid On-Highway Dump
Truck) NCII, Heavy Equipment Operations (Backhoe Loader) NCII, Heavy
Equipment Operations (Gantry Crane) NCII, Heavy Equipment Operations
(Container Stacker) NCII, and Heavy Equipment Operations (Screed) NCI.

BE IT RESOLVED FINALLY, that copies of this resolution and Training
Regulations (TRs) be published and disseminated to all concerned and shall be
effective fifteen (15) days upon its publication. All programs registered under or to
be under these training regulations must comply with the requirements of the
aforementioned training regulations. Graduates of TVET courses covered by the
aforementioned training regulations shall be required to undergo mandatory
assessment under the national assessment and certification system.
