**APPROVING AND PROMULGATING THE TRAINING REGULATION FOR CABLE
TV OPERATIONS AND MAINTENANCE NCIII**

WHEREAS, Section 14 item (b) of RA 7796 otherwise known as the TESDA Act of 1994, mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 55th TESDA Board Meeting which was held last 20 April 2007, the TESDA Board considered and approved Board Resolution No. 2007-11 on the prioritization of fifty three (53) titles for training regulations development for year 2007 where Antennas/CATV Installation was included;

WHEREAS, the concerned industry association (Philippine Cable Television Association) has endorsed for promulgation the Training Regulation for Cable TV Operations and Maintenance NCIII;

WHEREAS, in the 28th Standard Setting and Systems Development-TESDA Board-TESDA Secretariat Consultation Meeting held last 18 December 2007, the aforementioned training regulation was deliberated upon and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, in the 55th EXCOM-TESDA Board Meeting held 19 December 2007, 11:00 a.m. the EXCOM-TESDA Board endorsed favorably the Training Regulation for Cable TV Operations and Maintenance NCIII for consideration and approval of the TESDA Board.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 19 December, 2007, 1:00 p.m. approves the Training Regulation for Cable TV Operations and Maintenance NCIII.
