WHEREAS, the concerned industry association (Chamber of Furniture Industries of the Philippines, Inc.) has endorsed for promulgation the Training Regulation for Furniture Making (Finishing) NCII;

WHEREAS, in the 28<sup>th</sup> Standard Setting and Systems Development–TESDA Board-TESDA Secretariat Consultation Meeting held last 18 December 2007, the aforementioned training regulation was deliberated upon and favorably recommended to the EXCOM-TESDA Board for consideration;

WHEREAS, in the 55<sup>th</sup> EXCOM-TESDA Board Meeting held 19 December 2007, 11:00 a.m. the EXCOM-TESDA Board endorsed favorably the Training Regulation for Furniture Making (Finishing) NCII for consideration and approval of the TESDA Board.
