**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
LABORATORY AND METROLOGY/CALIBRATION SERVICES NCII, PLASTIC
MACHINE OPERATION NCII, PROCESS INSPECTION NCII, PAINTING MACHINE
OPERATION NCII AND TINSMITHING (AUTOMOTIVE MANUFACTURING) NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, in the 55th TESDA Board Meeting which was held last 20 April 2007, the TESDA Board considered and approved Board Resolution No. 2007-11 on the prioritization of fifty three (53) qualification titles for training regulations development for year 2007 which included the abovementioned qualification titles under the automotive manufacturing sub-sector;

WHEREAS, the concerned industry associations, the Center for Automotive Technology Corporation (CATC) and the Philippine Automotive Federation, Inc. (PAFI) have endorsed for promulgation the Training Regulations for Laboratory and Metrology/Calibration Services NC II, Plastic Machine Operation NCII, Process Inspection NCII, Painting Machine Operation NCII and Tinsmithing (Automotive Manufacturing) NCII;

WHEREAS, in the 29th and 30th Standard Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meetings held last 24 January 2008 and 15 February 2008, the aforementioned Training Regulations were deliberated upon and favorably recommended for consideration and approval of the TESDA Board;

WHEREAS, during the 56th EXCOM-TESDA Board Meeting held last 29 February 2008, the abovementioned qualification titles were endorsed favorably for consideration and approval of the TESDA Board.



Graduates of TVET courses covered by the aforementioned training regulations shall be required to undergo mandatory assessment under the national assessment and certification system.
