APPROVING THE AWARD OF CONTRACT TO MAXCOR INTER-VENTURES, CO. IN THE AMOUNT OF Php5,777,000.00 FOR THE PROCUREMENT OF ADDITIONAL ONE HUNDRED THREE (103) UNITS OF COMPUTERS FOR ENGLISH LANGUAGE PROFICIENCY PROGRAM FOR ILOILO PROVINCIAL OFFICE, TESDA REGION VI UNDER THE PRIORITY DEVELOPMENT ASSISTANCE FUND (PDAF) OF CONGRESSWOMAN JUDY J. SYJUCO

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the TESDA Region VI through its Bids and Awards Committee (BAC) in complying with the TESDA Circular issued and re-enacted on June 6, 2007 by TESDA Director General, Augusto "Boboy" Syjuco engaged to conduct the bidding for the project "Procurement of 103 Units Information Technology Equipment (Computers) and Software" by publishing an Invitation to Bid in newspaper of general circulation, and by posting the Invitation to Bid at the most conspicuous places of TESDA VI for a period of more than fourteen (14) calendar days;

WHEREAS, this procurement of "103 Units Information Technology Equipment (Computers) and Software" is funded through the Priority Development Assistance Fund (PDAF) FY2007 budget, RA 9401, SARO No. ROCS-07-09229 dated November 28, 2007 and bidding procedures under the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act", were adopted,

WHEREAS, the BAC, in exercising its functions and in accordance with procedures pursuant to RA No. 9184 has recommended through BAC Resolution No. 0804-002 the award of contract to MAXCOR Inter-Ventures, Co. as the winning bidder in the project "Procurement of 103 Units Information Technology Equipment (Computers) and Software".




