**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
MECHANICAL DRAFTING NCI, PRESS MACHINE OPERATION NCI, PLANT
MAINTENANCE NCI, TOOL AND DIE MAKING NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the concerned industry association (Metal Working Industries Association of the Philippines) has endorsed for approval of the TESDA Board the Training Regulations for Mechanical Drafting NCI, Press Machine Operation NCI, Plant Maintenance NCI, and Tool and Die Making NCII;

WHEREAS, in the 32nd Standard Setting and Systems Development Committee TESDA Board-TESDA Secretariat Consultation Meeting held on 13 May 2008, the aforementioned Training Regulations were deliberated upon and favorably recommended for consideration and approval of the TESDA Board;

WHEREAS, in the 57th EXCOM-TESDA Board Meeting held on 21 May 2008, 1:00 p.m. the EXCOM-TESDA Board endorsed favorably the approval of the Training Regulations for Mechanical Drafting NCI, Press Machine Operation NCI, Plant Maintenance NCI, Tool and Die Making NCII.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 21 May 2008; 2:30 p.m. approves the Training Regulations for Mechanical Drafting NCI, Press Machine Operation NCI, Plant Maintenance NCI, Tool and Die Making NCII.

BE IT RESOLVED FINALLY, that copies of this resolution and Training Regulations (TRs) be published and disseminated to all concerned and shall be effective fifteen (15) days upon its publication. All programs registered under or to be registered under these training regulations must comply with the requirements of the aforementioned training regulations. Graduates of TVET courses covered by the aforementioned training regulations shall be required to undergo mandatory assessment under the national assessment and certification system.


