**APPROVING AND PROMULGATING THE TRAINING REGULATIONS FOR
PHARMACY SERVICES NCII AND HILOT (WELLNESS) NCII**

WHEREAS, Section 14 item (b) of RA 7796 mandates that TESDA shall develop and establish a national system of skills standardization, testing and certification and to conduct research and development on various occupational areas in order to recommend policies, rules and regulations for effective and efficient skills standardization, testing and certification system in the country;

WHEREAS, the concerned industry associations, Health Care Industry Training Council (HCITC), National Consumer Affairs Council (NCAC), Association of Traditional Health Aid Givers (ATHAG), and Spa Association of the Philippines, Inc. (SAPI) have endorsed for promulgation the Training Regulations for Pharmacy Services NCII and Hilot (Wellness) NCII;

WHEREAS, there is need to train and qualify Pharmacy Aides and Hilot providers to ensure quality dispensing of affordable medicines and provision of quality health care and medical tourism services, respectively;

WHEREAS, in the 33rd Standard Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting held on 11 August 2008, the aforementioned Training Regulations were deliberated upon and favorably recommended to the TESDA Board for consideration and approval;

WHEREAS, during the 60th EXCOM-TESDA Board Meeting held 29 August 2008, the EXCOM-TESDA Board endorsed favorably the approval of the Training Regulations for Pharmacy Services NCII and Hilot (Wellness) NCII.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the TESDA Board in its meeting today, 29 August 2008 approves the Training Regulations for Pharmacy Services NCII and Hilot (Wellness) NCII.
