WHEREAS, the Republic of the Philippines has received a loan from the Asian Development Bank (ADB) towards the cost of the Technical Education and Skills Development Project (TESDP), and it intends to apply part of the proceeds of this loan to payments under the contracts for the Supply, Delivery, Installation, Testing, Training and Commissioning of various Civil Technology Tools and Equipment;
