**APPROVING THE AWARD OF CONTRACT TO AYALA SYSTEMS TECHNOLOGY,

WHEREAS, Section 8, paragraph 3 of Republic Act No. 7796 otherwise known as the "Technical Education and Skills Development Act of 1994" grants the TESDA Board the power to enter into, make, execute, perform and carry out domestic and foreign contracts subject to existing law, rules and regulations;

WHEREAS, in the exercise of this power, the TESDA Board shall approve all contracts both local and foreign entered into by the Technical Education and Skills Development Authority (TESDA);

WHEREAS, the Bids and Awards Committee (BAC) as mandated by Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act" is the body tasked to post invitation to bid, conduct pre-bid conferences, determine the eligibility of prospective bidders, receive and open bids, conduct the evaluation of bids, undertake post-qualification proceedings, and recommend award of contracts to the Head of the Procuring Entity;

WHEREAS, the Technical Education and Skills Development Authority (TESDA) conducted a bidding for the supply, delivery, installation and commissioning of various IT Equipment for eTESDA Centers with the Approved Budget for the Contract in the amount of **₱ 129,006,000.00**;

WHEREAS, during said bidding, the contract was awarded to **AYALA SYSTEMS TECHNOLOGY, INC**, as the bidder with the most responsive calculated bid per BAC Resolution No. 025-2008;

WHEREAS, the eTESDA Unit-PMO through its approved Terms of Reference intends to expand the current 40 eTESDA Centers within the TESDA Technology Institutions and TESDA Taguig Complex by adding 10 centers and provide additional computing goods such as hardware, software, peripherals, supplies and materials;

WHEREAS, Section 51 of the Implementing Rules and Regulations-A of R.A. No.9184 on Repeat Order states that this is a method of procurement of goods from the previous winning bidder on the following conditions:

- a) Contract prices of the repeat order must be the same as or lower than those in the original contract, provided that such prices are still the most advantageous to the Government after price verification;
- b) The repeat order will not result in splitting of contracts, requisitions or purchase orders, as provided for in Section 54.1 of this IRR-A;
- c) Except in cases duly approved by the GPPB, the repeat order shall be availed during of only within six (6) months from the date of the Notice to Proceed arising from the original contract; and
- d) The repeat order shall not exceed twenty-five percent (25%) of the quantity of each item in the original contract.

WHEREAS, during the 37th and 38th Finance TESDA Board and TESDA Secretariat Consultation Meeting last 15 October and 4 December 2008 respectively, the TESDA Secretariat through the Bids and Awards Committee recommended to award the additional various IT equipment for the eTESDA Centers in the total amount of **₱ 29,278,921.36** through Repeat Order from **AYALA SYSTEMS TECHNOLOGY, INC.** with breakdown as follows:
