WHEREAS, during the 46<sup>th</sup> TESDA Board Meeting on 19 May 2005, the TESDA Board Resolution No. 2005-08 "Adoption of the Basic Competency Standards as a pre-requisite for Training Delivery for all TVET Qualifications" was approved;

WHEREAS, in the 12<sup>th</sup> Standards Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting on 06 September 2005, it was agreed to review the competency standard from 1 to 20 and come up with the position paper indicating common competencies for all qualifications which includes basic writing, reading, and arithmetic;

WHEREAS, during the 40<sup>th</sup> Standards Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting on 11 May 2009, the body recommended to focus its efforts and resources on priority qualifications identified with partner industry bodies and associations on the basis of:

- 1. Priority needs of the industry sector
- 2. Nationwide application in terms of public interest/welfare
- 3. Employment generation and investment opportunities
- 4. The criteria for skills standardization and certification
  - Requires education and training;
  - Performance of the competency affects and endangers people's lives and limbs; and
  - Competency involves the handling of complex equipment, tools and supplies.

WHEREAS, during the 40<sup>th</sup> Standards Setting and Systems Development TESDA Board-TESDA Secretariat Consultation Meeting, 11 May 2009 the body recommended the inclusion of five (5) priority qualification titles for training regulations development for Year 2009: Adjudication, Surveying, Compressed Natural Gas (CNG) Vehicle Servicing, Institutional Caregiving NCIII, and Micro-Finance Field Operations Services;
