WHEREAS, to support and address the urgency of supplying demand for workers by employers both in the local and overseas market for Commercial Cooking NCII, there is a need to amend as follows the pertinent sections of the aforementioned Training Regulation as shown in the relevant pages attached hereto:

- 1. Section 1 Definition of Qualification page 2, last paragraph, to delete numbers 1, 2 and 3 from the term "Commis" and the terms "Gardemanger and Saucier". Hence, the paragraph is to read as, a person who has achieved this Qualification is competent to be employed in any of the following positions:
 - Commis
 - Pastry Cook
 - Hot-Kitchen Cook
 - Pantry Worker/Cold-Kitchen Cook
- Section 2 Competency Standards changes/recommendations were made on the following pages: 39, 46-47, 83, 92-93, 97-98 as indicated in the comments attached hereto.
- 3. Section 3 Training Standards page 113, Item 16 on "Curriculum Design Learning Outcomes" were updated based on the merging of Elements 1 & 2 into one Element for the Unit-Package prepared foodstuff as per Section 2.
- Section 4 National Assessment and Certification Arrangements pages 120-121, item 4.2 (minor editing in the paragraph).
- 5. Acknowledgements page 126, Inclusion of the Names of Experts as Review Panel Members in recognition of the technical assistance provided for the enhancement of the Training Regulation.
