- Retitling of Qualification from "Baking/Pastry Production NCII" to "Bread and Pastry Production NCII". (Hence, new title should be reflected in the Training Regulation cover page, Table of Contents, 1, 2, 4, 47, 53, 55- 57 and 62.
- Section 1 Definition of Qualification Core Competencies Unit No. TRS741341 – Prepare pastry and bakery products for patissiers was split into two units to read as:
 - TRS741379 Prepare and produce bakery products
 - TRS741380 Prepare and produce pastry products

Page 1 last paragraph – A person who has achieved this Qualification is competent to be:

- Commis 1, 2 and 3 Pastry is to read as: "Commis-Pastry"
- Section 2 Competency Standards The proposed changes/ recommendations in the Element, Performance Criteria, Range of Variable under the Core Competencies were based on the revised or additional units of competency as stated in section 1. (Changes/recommendations were made on the following pages: 29-30, 32-33, 36-37, 39, 41, 44-45).
